



Country context: Kingdom of Cambodia




- Population (2019): **16.5 million**
 - 76% <40 years old; 4.5% >65 years old
 - Majority (77%) live in rural areas
- GDP per capita, US\$ (2018): **1510** (Lower-middle-income country)
- Total health expenditure per capita, US\$ (2016): **79.6**
- 3 international airports, ground crossings with Viet Nam, Thailand and Lao PDR, 1 seaport






Epidemiology



Confirmed cases of COVID-19 by date of positive test and acquisition status, 18 June 2020 (N=129)



- 129 confirmed cases
- 91 cases imported from 11 countries
- Confirmed cases in
 12 provinces and in
 Phnom Penh
- 5 main clusters contained

How has Cambodia managed to contain the outbreak so far?



1. Strong leadership and coordination



- A whole-of-government, whole-of-society response
 has been activated, led by Samdech Techo Hun Sen,
 Prime Minister, with the public health response led by
 H.E. Prof. Mam Bunheng, Minister of Health
 - ➤ National Committee to Combat COVID-19, chaired by Samdech Prime Minister
 - ➤ Inter-Ministerial Committee to Combat COVID-19, chaired by Minister of Health
 - ➤ **Provincial COVID-19 Committees**, chaired by Provincial Governors
- Government developed and mobilized funding for the National Master Plan for COVID-19
- Ministry of Health convened Technical Working Groups to guide and support implementation





2. Past investments have built a functional public health system





- Multi-source surveillance for COVID-19 including event-based surveillance (with hotline) and expanded ILI/SARI surveillance
- Mobilization of 2910 Rapid Response Team
 (RRT) members to find cases, trace contacts and collect detailed information on movement
- Laboratory capacity for testing and detection of SARS-CoV-2 at Institute Pasteur Cambodia and National Institute of Public Health, including testing of ILI/ SARI → more than 28,000 tests conducted



3. Risk communication and community engagement

Messages disseminated through TV, radio and social media

- Timely and regular press releases, press conferences and media briefings
- Material developed specifically for drivers and garment factory workers
- Risk communication and community engagement monitoring and supervision plan
- Community engagement strategy being rolled out includes surveillance and response elements


4. Global solidarity and international cooperation






- Samdech Techo Hun Sen, Prime Minister decided to accept Westerdam cruise ship on humanitarian grounds and led the National Committee with national resource mobilization to combat Covid-19
- Close technical cooperation with WHO, US-CDC and Institute Pasteur Cambodia for surveillance, detection, and rapid response
- Financial and technical support from a number of bilateral and multilateral partners coordinated with support from WHO
- Regular attendance of WPRO Health Ministers and National IHR Focal Points meetings to **share experiences and lessons**
