### Concept

### **Background**

Greater Mekong Subregion (GMS) has been considered by many experts as a potential epicenter for spread of artemisinin resistance. Unless contained swiftly and effectively it may pose challenge to the rest of the world. Political commitment being at the centre of every successful public health response, governments of the GMS are joining hands to jointly combat the threat of resistance. In response to the serious malaria multi-drug resistance situation in the Greater Mekong Subregion (GMS), the GMS countries Cambodia, Yunnan Province/China, the Lao People's Democratic Republic (Lao PDR), Myanmar, Thailand and Viet Nam in 2015 adopted a joint malaria elimination strategy and are accelerating their efforts to eliminate malaria by latest 2030. Significant progress has been achieved: between 2012 and 2016, the number of reported malaria cases in the GMS fell by 74%, and the number of malaria-related deaths fell by 91%. However, multi-drug resistance – including artemisinin partial resistance and partner drug resistance – has spread from Western to Eastern Cambodia, and is affecting parts of North-East Thailand, and southern Lao PDR and Viet Nam. Many challenges remain, including availability and effective use of authentic good quality medicines, access to malaria interventions for all populations at risk, and high quality case-based surveillance.

The High-level Meeting to Accelerate the Elimination of Malaria in the Greater Mekong Subregion by 2030 was convened by the Ministry of Health and Sports, Myanmar, on 8<sup>th</sup> December 2017 at Naypyidaw, in close collaboration with the World Health Organization (WHO) and the Asia Pacific Leaders Malaria Alliance (APLMA). Representatives from the six GMS countries stressed that eliminating malaria in the GMS required urgent and coordinated action, with support from implementing agencies, funders and other partners. A 'Ministerial Call for Action to Eliminate Malaria in the Greater Mekong Subregion by 2030' was endorsed by the country representatives and supported by partners. The High-level Meeting recommended that the Ministerial Call for Action should be signed by all GMS countries' Ministers of Health on the sidelines of the WHA71 in May 2018 in Geneva. This meeting brings to an end a strong political dialogue process started few months back amongst the ministries of health of the GMS through a signing of declaration by the ministers themselves as well as laying an important milestone of combating resistance to malaria as a greater public good for the whole world.

## Objective

Signing of the 'Ministerial Call for Action to Eliminate Malaria in the Greater Mekong Subregion by 2030' by the 6 GMS countries' Ministers of Health.

# **Expected Results**

The political commitment expressed in the signing of the 'Ministerial Call for Action to Eliminate Malaria in the Greater Mekong Subregion by 2030' will accelerate malaria elimination in the GMS. While the Call for Action emphasizes the country-led efforts, it also focuses on the importance of the joint subregional approach.
