Recognizing that certain estimates must necessarily remain provisional,

- 1. AUTHORIZES the financing from the Real Estate Fund of the expenditures indicated under Section III of the Director-General's report, at an estimated cost of US\$ 50 000;
- 2. AUTHORIZES the transfer from the Real Estate Fund to Casual Income the amount of US\$ 2 049 000.
