# Proposed budget 2000-2001

# Regular budget allocations to regions, and use of extrabudgetary funds in the regions

**Progress report by the Director-General** 

#### **BACKGROUND**

- 1. In their recent review of the Constitution, the governing bodies noted that: (1) regular budget allocations had not been based on objective criteria; (2) each region's share of the allocations had remained largely unchanged since the early days of the Organization; (3) other organizations of the United Nations system had adopted objective criteria to ensure more equitable distribution of resources to country programmes; (4) there was a need for collective agreement on how two basic principles which govern WHO's work, namely equity and support to countries, particularly those in greatest need, should be applied to future allocations.
- 2. Against this background, the Fifty-first World Health Assembly adopted resolution WHA51.31, guiding the Director-General on how to establish allocations to the regions for the financial period 2000-2001 and subsequent periods. The resolution also requested the Director-General to ensure that the allocations in 2000-2001 to all least developed countries would not be less than for 1998-1999 and
  - (i) to report to the Executive Board and the World Health Assembly on an annual basis, any further refinement, development or modification to the allocation process in order to ensure response to health needs and the equitable allocation of resources of the Organization;
  - (ii) to report to the Executive Board at its 103rd session on the overall use of extrabudgetary funds in regional, intercountry and country programmes for the previous three bienniums (see Annex).

## **CURRENT SITUATION**

3. Following the adoption of resolution WHA51.31, the model outlined therein was applied to the initially established planning allocations for the biennium 2000-2001. The application used advance information from the 1998 Health Development Index (published by UNDP), together with updated

information on immunization levels and population. The results of the application of the model were then analysed in the context of the decisions and requests outlined in the resolution, including the needs of least developed countries.

- 4. In June 1998, the earlier planning allocations for the regions and the global and interregional activities for 2000-2001 were amended. Least developed countries in regions where the allocation was being reduced received a compensation by a transfer of US\$ 4.2 million from the global and interregional allocation. The Regional Directors revised the regional parts of their budget proposals accordingly and regional committees reviewed these on the basis of thorough and complete documentation in the autumn of 1998.
- 5. The Director-General's budget proposals<sup>1</sup> incorporate the amended regional allocations and take into account programme modifications suggested by regional committees.
- 6. The impact of changing international social and economic conditions and the impact of the new process on countries will be monitored in the context of work under way on the evidence base and health sector development. As requested by resolution WHA51.31, the Director-General will report annually to the Executive Board and the Health Assembly on the working and the impact of the new process for regular budget allocations.

## **ACTION BY THE EXECUTIVE BOARD**

7. The Executive Board is invited to take note of this first progress report by the Director-General on the subject.
