



Status of collection of assessed contributions, including Members in arrears in the payment of their contributions to an extent that would justify invoking Article 7 of the Constitution

Report by the Director-General

STATUS OF COLLECTION

1. In order for WHO to deliver the approved programme budget in full, contributions from Member States must be received in full and on time. Payments are due annually as of 1 January for the year to which they relate. Late payment has been of serious concern to successive Executive Boards and Health Assemblies.




Figure 2. Payment status of Member States and Associate Members in respect of current-year contributions to the effective working budget

2. At 31 December 2006, the rate of collection for the year was 89%, marginally lower than as at 31 December 2005 (see Annex 1, Figure 1). Of Member States, 133 have paid in full and a further 25 Members have paid in part (see Annex 1, Figure 2). Those Member States yet to make full payments of assessed contributions for 2006 (and prior years, if applicable) are urged to make such payments as soon as possible so that the budget may be fully financed.

3. Annex 2 shows the status of collection of annual regular budget contributions as at 31 December 2006, and lists all amounts due from each Member State, up to and including 2006. Unpaid contributions include amounts that are due as at 31 December 2006, and amounts due in future under special arrangements authorized by the Health Assembly, but which may be paid in the future under an instalment scheme. On 31 December 2006, a total of some US\$ 87 million was owing from Member States, with a further US\$ 56 million due under special arrangements referred to above (see Annex 2, Sections 1 and 2). The equivalent figures at 31 December 2005 were US\$ 82 million and US\$ 58 million respectively.

4. The total value of payments received in advance for 2007 is US\$ 52 million, which is slightly lower than the equivalent figure for 2006 of US\$ 55 million; 27 Member States have paid in full in advance, slightly more than last year (see Annex 2, Section 3).

MEMBERS IN ARREARS

5. Article 7 of the Constitution states that “If a Member fails to meet its financial obligations to the Organization ... the Health Assembly may ... suspend the voting privileges and services to which a Member is entitled”.

6. In accordance with resolution WHA41.7, if at the time the Health Assembly opens, a Member is in arrears in the payment of its financial contributions in an amount which equals or exceeds the amount of the contributions due from it for the preceding two full years, the Health Assembly will adopt a decision, unless there are exceptional circumstances justifying a different measure, under which the voting privileges of the Member will be suspended as from the opening day of the following Health Assembly, if at that time the Member is still in arrears to the extent referred to. If the Member is no longer in arrears to the said extent, the decision will lapse and the suspension will not take effect.

7. Pursuant to resolution WHA41.7, subsequent Health Assemblies have adopted resolutions whereby the voting privileges of the 12 Member States listed in Annex 3 have been suspended, the suspension to continue at the Sixtieth and subsequent Health Assemblies until the arrears have been reduced to a level below the amount that would justify invoking Article 7 of the Constitution.

8. Pursuant to the adoption by the Health Assembly of resolution WHA59.5, the voting privileges of Democratic Republic of Congo and Dominica will be suspended as from the opening of the Sixtieth World Health Assembly in May 2007, if at that time these Members are still in arrears in the payment of their contributions to an extent that would justify invoking Article 7 of the Constitution.

9. Four other Member States, namely Belarus, Cape Verde, Iran and Palau, are currently in arrears in the payment of their contributions in amounts that equal or exceed the amounts due from them for the preceding two full years, as shown in Annex 3.

10. Immediately before the opening of the Sixtieth World Health Assembly, the Director-General will report further to the Programme, Budget and Administration Committee of the Executive Board on the Members referred to in paragraph 9 above so that the Committee may formulate recommendations to the Health Assembly based on the provisions of resolution WHA41.7 and the status of the arrears at that time.

11. If at that time the Members concerned are still in arrears to the extent referred to in paragraph 9 above and pursuant to resolution WHA41.7, the Sixtieth World Health Assembly will adopt a decision, unless there are exceptional circumstances justifying a different measure, by which the voting rights of these four Member States will be suspended as from the opening day of the Sixty-first World Health Assembly in May 2008.

ACTION BY THE EXECUTIVE BOARD

12. The Executive Board is invited to note the report.

percentage collected as at 31 December, from 1997 to 2006**
