## **Appointment of the Regional Director for the Americas**

- 1. The present appointment of Dr Carissa Etienne as Regional Director for the Americas expires on 31 January 2023.
- 2. The 30th Pan American Sanitary Conference (seventy-fourth session of the Regional Committee of the World Health Organization for the Americas) in accordance with its Rules of Procedure, elected Dr. Jarbas Barbosa Da Silva Jr. as Director of the Pan American Sanitary Bureau for a period of five years, to begin on 1 February 2023, and decided to submit to the Executive Board the name of Dr. Jarbas Barbosa Da Silva Jr. for appointment as Regional Director for the Americas.
- 3. The text of the relevant resolution is given below:

ELECTION OF THE DIRECTOR OF THE PAN AMERICAN SANITARY BUREAU AND NOMINATION OF THE REGIONAL DIRECTOR OF THE WORLD HEALTH ORGANIZATION FOR THE AMERICAS

THE 30th PAN AMERICAN SANITARY CONFERENCE.

Bearing in mind Articles 4.E and 21.A of the Constitution of the Pan American Health Organization, which provide that the Pan American Sanitary Bureau shall have a Director elected at the Conference by the vote of a majority of the Members of the Organization;

Bearing in mind Article 4 of the Agreement between the World Health Organization and the Pan American Health Organization and Article 52 of the Constitution of the World Health Organization, which establish the procedure for the appointment of Regional Directors of the World Health Organization;

Satisfied that the election of the Director of the Pan American Sanitary Bureau has been held in accordance with the established rules and procedures,

## **RESOLVES:**

1. To declare Dr. Jarbas Barbosa Da Silva Jr. elected Director of the Pan American Sanitary Bureau for a period of five years beginning on 1 February 2023 and ending on 31 January 2028.

2. To submit to the Executive Board of the World Health Organization the name of Dr. Jarbas Barbosa Da Silva Jr. for appointment as Regional Director of the World Health Organization for the Americas for the same period.

Considering the provisions of Article 52 of the Constitution of the World Health Organization;

Considering the nomination made by the Regional Committee for the Americas at its seventy-fourth session,

- 1. APPOINTS Dr. Jarbas Barbosa Da Silva Jr. as Regional Director for the Americas as from 1 February 2023;
- 2. AUTHORIZES the Director-General to issue a contract to Dr. Jarbas Barbosa Da Silva Jr. for a period of five years as from 1 February 2023, subject to the provisions of the Staff Regulations and Staff Rules.
