## **Report on credentials**

1. The Bureau of the Intergovernmental Negotiating Body on a Protocol on Illicit Trade in Tobacco Products examined on 15 March 2010 the credentials delivered to the Convention Secretariat in accordance with Rule 18 of the Rules of Procedure for the Conference of the Parties.
2. The credentials of the Representatives of the Parties shown in the Annex hereto were found to be in conformity with the Rules of Procedure. It is therefore proposed that the Intergovernmental Negotiating Body accept the credentials of those Parties.
3. The Bureau examined communications received from the Parties listed below which, because they were not original documents, could not be considered as constituting formal credentials. It is therefore recommended to the Intergovernmental Negotiating Body that they be entitled to participate provisionally in the session with all rights in the Negotiating Body, pending the arrival of their formal credentials:

Angola, Bolivia (Plurinational State of), Central African Republic, Chile, Djibouti, Egypt, Equatorial Guinea, Guatemala, Guinea-Bissau, Iraq, Marshall Islands, Mauritius, Micronesia (Federated States of), Nicaragua, Sao Tome and Principe, Solomon Islands, and Zambia.
