1. REPORT OF THE SUB-DIVISION ON PROGRAMME (Agenda item 16)
(Document EM/RC8A/4 Annex I)

Dr. TABIBZADEH (Iran), Chairman and Rapporteur of the Sub-Division on Programme, submitted the report of the Sub-Division.

Dr. TABA, Regional Director, said that a paragraph had inadvertently been omitted from the text of the draft resolution on Drug Addiction (document EM/RC8A/R.12). The paragraph, which should follow paragraph (1), should read:

RECOMMENDS to Governments in the Region to take the necessary steps for the medical treatment of addicts;"

and the subsequent paragraphs should be renumbered accordingly.

In reply to a comment made by the Representative of Iraq, the REGIONAL DIRECTOR said that note had been taken of the observations regarding the training of statisticians made during the discussion on vital and health statistics.

The adoption of the Report was moved by Dr. SHOIB (United Arab Republic) and seconded by Dr. ABU SHALEMA (Sudan).

Decision: The Report of the Sub-Division on Programme was unanimously adopted.

Dr. MOFIDI (Iran) expressed his appreciation for the invitation extended by the Government of Tunisia to hold the 1960 Session of Sub-Committee A in that country.
