## 1. SUMMARY

As of 30 April 2008, the rate of collection of annual contributions in respect of the regular budget is lower than in 2007. Out of a total amount of \$ 470 062 155, \$ 229 031 953 or 48.72% has been collected, as compared to 58.29% in 2007. Whereas 89 Members had paid their contributions in full and 33 Members in part, 73 Members had not yet paid any part of their assessment. Advance payments in respect of the year 2009 contributions are listed on page 8 of this statement.

## 1. RESUME

Au 30 avril 2008, le taux de recouvrement des contributions annuelles au budget ordinaire est moins élevé qu'en 2007. Pour un total de \$ 470 062 155 mis en recouvrement les encaissements atteignent \$ 229 031 953 soit 48.72% contre 58.29% en 2007. Alors que 89 Membres ont versé leur contribution en totalité et 33 en partie, 73 Membres n'ont encore fait aucun versement. Les paiements en avance des contributions pour l'an 2009 figurent en page 8 de ce rapport.
