Twelfth meeting of Committee A

– **Draft sixth report of Committee A**

The draft sixth report of Committee A, document (draft) A58/60, containing the following resolution, was read out by the Rapporteur (Dr Ray Busuttill [Malta]) and adopted:

- *Sustaining the elimination of iodine deficiency disorders*

Discussion of this subitem resumed and five delegations took the floor. In accordance with Rule 49 of the Rules of Procedure of the World Health Assembly, the Chairman gave the floor to the representatives of three nongovernmental organizations who made statements. The Secretariat was invited to respond to the issues raised.

The report of the Secretariat contained in document A58/23 Add.1 was noted, closing the agenda subitem.

Item 13.18

– **Ministerial Summit on Health Research**

The Chairman opened this subitem and drew the Committee's attention to the draft resolution contained in document A58/22: *Ministerial Summit on Health Research*. The floor was given to the representative of the Executive Board, followed by 17 delegations.

In accordance with Rule 49 of the Rules of Procedure of the World Health Assembly, the Chairman gave the floor to the representatives of two nongovernmental organizations who made statements. The Secretariat responded to the issues raised.

The draft resolution will be considered at an informal working group. The Committee will be informed as to the scheduling of the working group later in the session.

The agenda subitem remained open.

– **Scaling up treatment and care within a coordinated and comprehensive response to HIV/AIDS**

The Chairman opened the agenda subitem and invited 24 delegations to take the floor. In accordance with Rule 48 of the Rules of Procedure of the Health Assembly, the Chairman invited the observer of the International Federation of Red Cross and Red Crescent Societies to make a statement. Two representatives of the Secretariat took the floor to comment on the issues raised. The Committee noted the report contained in document A58/23, closing the agenda subitem.

The Chair of the informal working group (United Kingdom of Great Britain and Northern Ireland) reported on the discussions of the group on the draft resolution: *Improving the containment of antimicrobial resistance*, contained in document A58/A/Conf.Paper No.10 Rev.1. The draft resolution was approved.

In accordance with Rule 48 of the Rules of Procedure of the World Health Assembly, the Chairman gave the floor to the representative of the International Atomic Energy Agency who made a statement.

The draft resolution: *United Nations reform process and WHO's role in harmonization of operational development activities at country level*, contained in document A58/B/Conf.Paper No.4, was approved as amended.
