The Chairman called upon the Rapporteur, Dr Amara Cisse (Guinea), to read out the second draft report of Committee A, document (draft) A59/49 containing one resolution entitled:

and the third draft report of Committee A, document (draft) A59/50 containing one resolution entitled:

- *Implementation by WHO of the recommendations of the Global Task Team on Improving AIDS Coordination among Multilateral Institutions and International Donors*

The resolutions were approved and the draft reports were adopted.

The programme of work was amended so that subitem 11.4 *Sickle-cell anaemia*, could be taken up for consideration later in the day. This was accepted by the Committee.

- The Chairman opened the item and gave the floor to the representative of the Executive Board who informed the Committee on the January 2006 session of the Board. 22 delegations were invited to comment.
- In accordance with Rules 48 and 49 of the Rules of Procedure of the World Health Assembly, the Chairman gave the floor to the representative of the United Nations Population Fund and one nongovernmental organization who made statements. At the invitation of the Chairman, the Secretariat responded to the issues raised.
- It was proposed that the agenda item remains open pending further consideration and discussion of the amendments during a meeting of interested parties scheduled the same day. This proposal was accepted by the Committee.
- Item 11.7 **Prevention of avoidable blindness and visual impairment**
- The Chairman gave the floor to the representative of the Executive Board, who made some explanatory remarks. The Committee was invited to consider draft resolution EB117.R4 *Prevention of avoidable blindness and visual impairment*, contained in document EB117/2006/REC/1.
- The debate opened with 22 delegations taking the floor. Consideration of this item will resume at the next meeting of Committee A.

At the invitation of the Chairman, 33 delegations took the floor, seven of whom suggested amendments to the draft resolution.
- In accordance with Rule 49 of the Rules of Procedure of the World Health Assembly, the Chairman gave the floor to the representatives of four nongovernmental organizations who made statements. The Secretariat responded to the issues raised.
- The Chairman gave the floor to the Secretariat who read out the costing and the various amendments proposed in the draft resolution *Infant and young child nutrition 2006*, contained in document A59/A/Conf.Paper No. 1. At the request of the Chairman, one delegation gave further clarifications.

We also would like to remind you that security screening checks during the World Health Assembly (WHA), have increased for both vehicles and pedestrians seeking access to the Palais des Nations and to the conference room areas. As a result, we would advise that you please come prepared with required proof of identity and proper accreditation to facilitate your entry into the WHA area.
