1. SUMMARY

As of 30 April 2007, the rate of collection of annual contributions in respect of the regular budget is lower than in 2006. Out of a total amount of \$ 451 114 540, \$ 262 964 913 or 58.29% has been collected, as compared to 58.39% in 2006. Whereas 88 Members had paid their contributions in full and 41 Members in part, 65 Members had not yet paid any part of their assessment. Advance payments in respect of the year 2008 contributions are listed on page 8 of this statement.

1. RESUME

Au 30 avril 2007, le taux de recouvrement des contributions annuelles au budget ordinaire est moins élevé qu'en 2006. Pour un total de \$ 451 114 540 mis en recouvrement les encaissements atteignent \$ 262 964 913 soit 58.29% contre 58.39% en 2006. Alors que 88 Membres ont versé leur contribution en totalité et 41 en partie, 65 Membres n'ont encore fait aucun versement. Les paiements en avance des contributions pour l'an 2008 figurent en page 8 de ce rapport.
