Status of collection of assessed contributions including Members in arrears to an extent which would justify invoking Article 7 of the Constitution

Report by the Director-General

BACKGROUND

1. For the Organization to deliver its approved programme in full, the contributions from Member States have to be received in total and on time. Low annual collection rates have been of serious concern to successive Executive Boards and Health Assemblies.¹

STATUS OF COLLECTION OF ASSESSED CONTRIBUTIONS AS AT 31 DECEMBER 1998

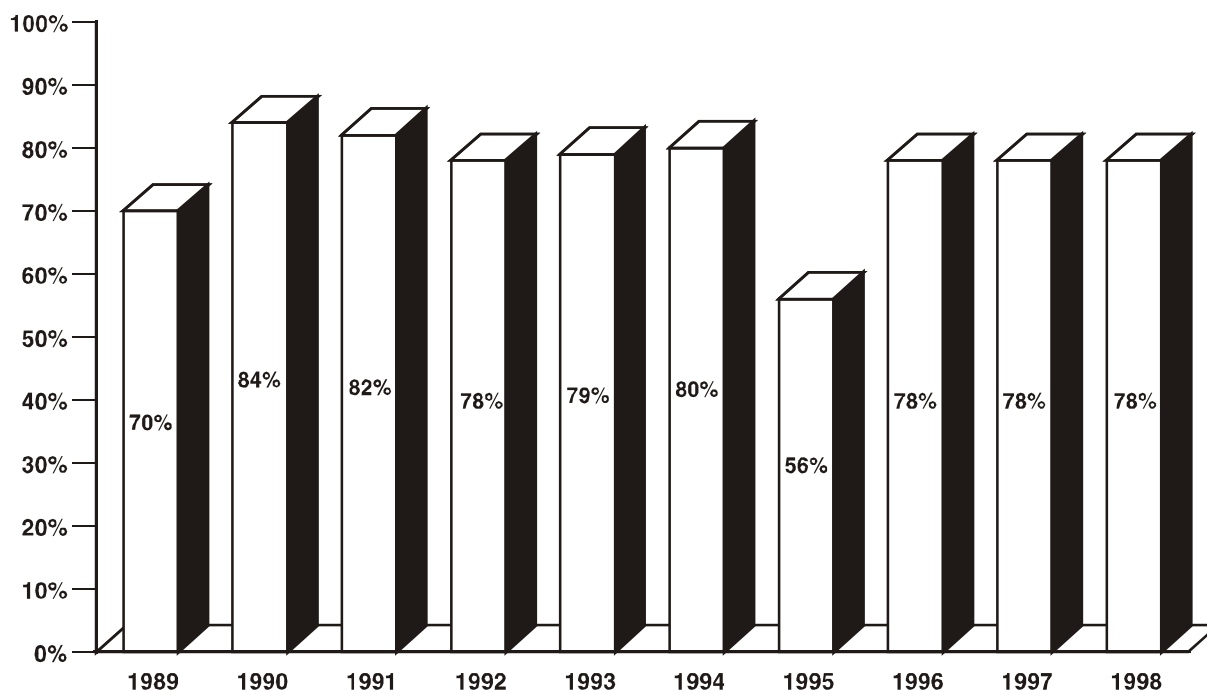
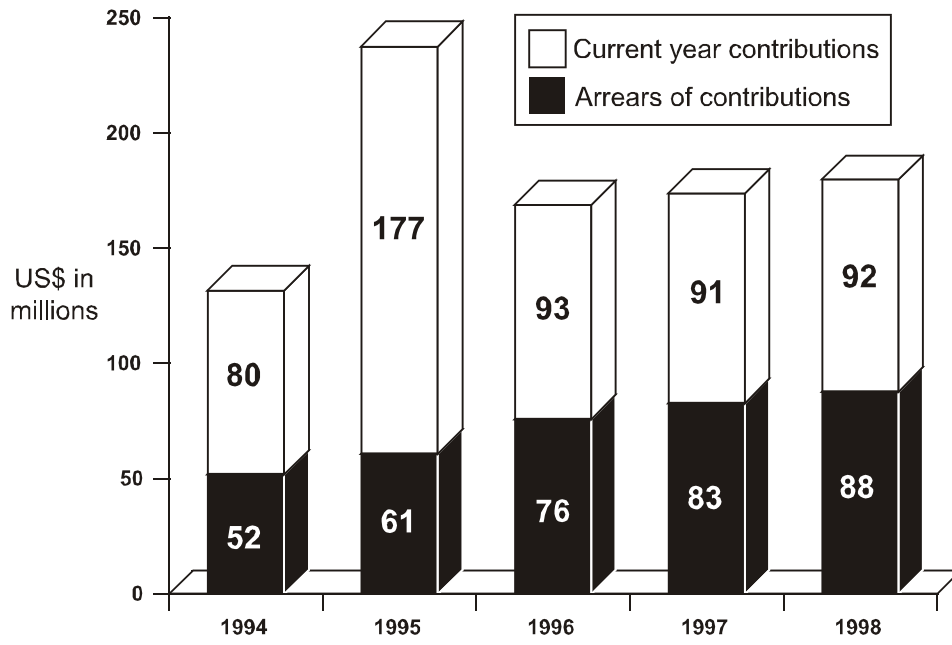


FIGURE 2. PAYMENT STATUS OF MEMBER STATES AND ASSOCIATE MEMBERS IN RESPECT OF CURRENT-YEAR CONTRIBUTIONS TO THE EFFECTIVE WORKING BUDGET

2. In 1998 the rate of collection was only 77.9% of the amount due from the Member States to the effective working budget (Annex 1, Figure 1). Only 105 of the 193 Member States had paid their contributions in full (Annex 1, Figure 2). The large amounts unpaid as at 31 December 1998 - US\$ 92 million of 1998 contributions, and US\$ 88 million for previous years (Annex 1, Figure 3) - mean that the Organization cannot fulfil its programme activities without significant internal borrowing. The status of collection of contributions from all Member States is shown in Annex 2.

3. All Member States are required under Financial Regulation 5.6 to pay their contributions as of 1 January of the year in which they are due. The current incentive scheme, to reward Members to pay on time, appears to be less than effective. Late payment imposes a significant administrative burden on the Organization and ties up resources which could in other circumstances be more productively used to the benefit of technical activities.

4. Late or no payment of assessed contributions inhibit further reform and efficiency gains in WHO. Unless the situation improves, the estimated deficit at 31 December 1999 will require internal borrowing of US\$ 65 million or more.

MEMBERS IN ARREARS TO AN EXTENT WHICH WOULD JUSTIFY INVOKING ARTICLE 7 OF THE CONSTITUTION

5. Article 7 of the Constitution states that “If a Member fails to meet its financial obligations to the Organization ... the Health Assembly may ... suspend the voting privileges and services to which a Member is entitled.”

6. In accordance with previous Health Assembly resolutions, the voting privileges of 25 Members (Afghanistan, Antigua and Barbuda, Armenia, Azerbaijan, Bosnia and Herzegovina, Central African Republic, Chad, Comoros, Djibouti, Dominican Republic, Equatorial Guinea, Georgia, Guinea-Bissau, Iraq, Kazakhstan, Kyrgyzstan, Latvia, Liberia, Niger, Republic of Moldova, Somalia, Tajikistan, Turkmenistan, Ukraine and Yugoslavia) were suspended, and the suspension would continue at the Fifty-second and subsequent Health Assemblies until the arrears have been reduced to a level below the amount which would justify invoking Article 7 of the Constitution.

7. Pursuant to the adoption by the Fifty-first World Health Assembly of resolution WHA51.2, with the required two-thirds majority, the voting privileges of two Members - Ecuador and Gambia - will be suspended as from the opening of the Fifty-second World Health Assembly on 17 May 1999 if at that time these Members are still in arrears in the payment of their contributions to an extent which would justify invoking Article 7 of the Constitution.

8. The following seven other Members are in arrears in the payment of their contributions in amounts which equal or exceed the amounts due from them for the preceding two full years: Argentina, Guinea, Libyan Arab Jamahiriya, Lithuania, Nauru, Solomon Islands and Yemen. The status of the arrears of contributions of these seven Members is as shown in Annex 3.

9. Pursuant to resolution WHA41.7, unless there are exceptional circumstances justifying a different measure, the Fifty-second World Health Assembly will adopt a decision under which the voting rights of these Members will be suspended as from the opening day of the Fifty-third World Health Assembly in May 2000, if at that time the Members concerned are still in arrears to the extent referred to in paragraph 8 above.

10. The Director-General will continue efforts to collect the unpaid arrears of contributions from the Members concerned. An analysis of all Members subject to Article 7 is shown in Annex 4. She will report further to the Administration, Budget and Finance Committee of the Executive Board on the seven Members referred to in paragraph 8 immediately before the opening of the Fifty-second World Health Assembly so that the Committee can formulate recommendations to the Health Assembly based on the provisions of resolution WHA41.7 and the status of the arrears at that time.

ACTION BY THE EXECUTIVE BOARD

11. Having heard the advice of the Administration, Budget and Finance Committee on the status of collection of assessed contributions, the Board may wish to formulate an appropriate resolution to the Health Assembly.

12. No action is required of the Board in respect of those Members whose voting privileges remain suspended under previous Health Assembly resolutions, or of those Members which may lose their voting privileges as from 17 May 1999 under resolutions WHA51.2.

Percentage collected as at 31 December 1989 through 1998

1. SUMMARY

As of 31 December 1998, the rate of collection of annual contributions in respect of the regular budget is lower than in 1997. Out of a total amount of \$ 418 751 000, \$ 326 377 216 or 77.94% has been collected, as compared to 78.27% in 1997. Whereas 105 Members had paid their contributions in full and 25 Members in part, 63 Members had not yet paid any part of their assessment. Advance payments in respect of 1999 contributions are listed on page 7 of this statement.

1. RESUME

Au 31 décembre 1998, le taux de recouvrement des contributions annuelles au budget régulier est moins élevé qu'en 1997. Pour un total de \$ 418 751 000 mis en recouvrement les encaissements atteignent \$ 326 377 216 soit 77.94% contre 78.27% en 1997. Alors que 105 Membres ont versé leur contribution en totalité et 25 en partie, 63 Membres n'ont encore fait aucun versement. Les paiements en avance des contributions pour 1999 figurent en page 7 de ce rapport.
