## Status of collection of assessed contributions including Members in arrears to an extent which would justify invoking Article 7 of the Constitution

## **Report by the Director-General**

## BACKGROUND

1. In order that WHO may deliver the approved programme budget in full, contributions from Member States must be received in full and on time. Payments are due as of 1 January for the year to which they relate. Low annual rates of collection have been of serious concern to successive Executive Boards and Health Assemblies.

2. In 2000 the rate of collection was 87%. This is the highest rate for the past 15 years (see Annex 1, Figure 1). Annex 2, Statement showing the status of collection of annual regular budget contributions at 31 December 2000, lists all amounts due from each Member State.




Figure 2. Payment status of Member States and Associate Members in respect of current-year contributions to the effective working budget

3. As at 31 December 2000, 119 Member States had paid in full; a further 25 Members had paid in part (see Annex 1, Figure 2).

4. Unpaid contributions include amounts that are due as at 31 December, and amounts due under special arrangements authorized by the Health Assembly but which may be paid in the future under an instalment scheme. On 31 December 2000 a total of US\$ 143.7 million was owing from Member States, including US\$ 6.6 million due under special arrangements referred to above (see Annex 2, Sections 2 and 3). The equivalent total owing at 31 December 1999 was US\$ 164.8 million.

5. Despite the improvement in 2000, programme activities could not be fulfilled without significant recourse to internal borrowing and the Working Capital Fund. The continuing high amount due for earlier years continues to inhibit efficient management and reform in WHO.

6. However, payments received in advance for 2001 are slightly higher than for 2000 (see Annex 2, Section 4). Thirty-two Members have paid their contributions in full for 2001, whereas 16 paid in advance last year.

7. Article 7 of the Constitution states that "If a Member fails to meet its financial obligations to the Organization ... the Health Assembly may ... suspend the voting privileges to which a Member is entitled".

8. In accordance with previous Health Assembly resolutions, the voting privileges of the 23 Member States listed in Annex 3 have been suspended, the suspension to continue at the Fifty-fourth and subsequent Health Assemblies until the arrears have been reduced to a level below the amount which would justify invoking Article 7 of the Constitution. As at 31 December 2000, none of these Member States had yet made payments that would result in the restoration of their voting privileges.

9. Pursuant to the adoption by the Fifty-third World Health Assembly of resolution WHA53.2, the voting privileges of Nauru and Nigeria will be suspended as from the opening of the Fifty-fourth World Health Assembly on 14 May 2001 if at that time these Members are still in arrears in the payment of their contributions to an extent which would justify invoking Article 7 of the Constitution.

10. Thirteen other Members are in arrears in the payment of their contributions in amounts which equal or exceed the amounts due from them for the preceding two full years, as listed in Annex 3.

11. Pursuant to resolution WHA41.7, unless there are exceptional circumstances justifying a different measure, the Fifty-fourth World Health Assembly will adopt a decision under which the voting rights of these Members will be suspended as from the opening day of the Fifty-fifth World Health Assembly in May 2002, if at that time the Members concerned are still in arrears to the extent referred to in paragraph 10 above.

12. An analysis of all Members subject to Article 7 is shown in Annex 4. The Director-General will report further to the Administration, Budget and Finance Committee of the Executive Board on the 13 Members referred to in paragraph 10 immediately before the opening of the Fifty-fourth World Health Assembly so that the Committee can formulate recommendations to the Health Assembly based on the provision of resolution WHA41.7 and the status of the arrears at that time.

13. The Director-General will continue to increase efforts to collect the unpaid arrears of contributions from the Members concerned.

## ACTION BY THE EXECUTIVE BOARD

14. The Executive Board is invited to note the above report.

#### 1. SUMMARY

As of 31 December 2000, the rate of collection of annual contributions in respect of the regular budget is higher than in 1999. Out of a total amount of \$ 421 305 220, \$ 365 083 120 or 86.66% has been collected, as compared to 84.58% in 1999. Whereas 119 Members had paid their contributions in full and 25 Members in part, 49 Members had not yet paid any part of their assessment. Advance payments in respect of the year 2001 contributions are listed on page 7 of this statement.

#### 1. RESUME

Au 31 décembre 2000, le taux de recouvrement des contributions annuelles au budget régulier est plus élevé qu'en 1999. Pour un total de \$ 421 305 220 mis en recouvrement les encaissements atteignent \$ 365 083 120 soit 86.66% contre 84.58% en 1999. Alors que 119 Membres ont versé leur contribution en totalité et 25 en partie, 49 Membres n'ont encore fait aucun versement. Les paiements en avance des contributions pour l'an 2001 figurent en page 7 de ce rapport.
