Assessments for 2004-2005

Note by the Secretariat

1. In paragraph 9 of document EB111/15, it was noted that the United Nations General Assembly has been considering recommendations of its Committee on Contributions in respect of the rate of assessment for Afghanistan, Argentina and the Democratic Republic of Timor-Leste, and that any amendment to the United Nations scale for 2003 would be submitted to the Executive Board as an addendum to document EB111/15. Further developments have taken place, which are outlined below.
2. By resolution 57/4B, the United Nations General Assembly fixed the rates of assessment in 2003 for Afghanistan at 0.001% and for Argentina at 0.969%, as ad hoc adjustments, and noted that this decision was neither a precedent nor should it have automatic implication for the apportionment of the expenses of the specialized agencies or IAEA. In the same resolution the General Assembly also decided that the rate of assessment for Timor-Leste, admitted to membership of the United Nations on 27 September 2002, should be 0.001% for 2002 and 2003.
3. The Executive Board may wish to consider whether to recommend to the Fifty-sixth World Health Assembly that similar ad hoc adjustments should be made in respect of the assessments due from Afghanistan and Argentina for 2003. The effect of such an ad hoc adjustment of the rate of contribution of these two countries would be as shown in Annex 1.
4. Although the United Nations was able to finance these reductions from the entry of another new Member, Switzerland, this option is not available to WHO, of which Switzerland has been a Member for many years. If the Executive Board were to decide to recommend ad hoc adjustments for Afghanistan and Argentina for 2003, it may wish to consider recommending to the Health Assembly that the amount of US\$ 611 135, representing the decrease in contribution, should be provided from the Miscellaneous Income account by way of further relief for Afghanistan and Argentina.
5. The proposed WHO scale of assessments for 2004-2005, as contained in document EB111/15, has been revised to take into account the adoption by the United Nations of these ad hoc adjustments for 2003 and is set out in the draft resolution proposed below.
6. The comparison between United Nations scales of assessment and corresponding WHO percentages contained in the Annex to document EB111/15 has been amended to reflect the new figures and is set out in Annex 2 to the present document.
7. Document EB111/15 reflected a proposed WHO rate of assessment for Timor-Leste at 0.001%. In view of the decision of the United Nations General Assembly to adopt the same rate for 2003 for the United Nations, no change is proposed to the WHO scale of assessments for 2004-2005.

8. In accordance with Financial Regulation 6.12, the Executive Board may wish to recommend to the Health Assembly that Timor-Leste should be assessed in the amount of US\$ 1053 for 2002, and US\$ 4213 for 2003, which amounts when received shall be credited to Miscellaneous Income. The amount of US\$ 1053 for 2002 is calculated on a pro rata basis, recognizing that Timor-Leste became a Member of WHO on 27 September 2002.

ACTION BY THE EXECUTIVE BOARD

9. The Executive Board is invited to note the above information, and to consider the following draft resolution, which supersedes that contained in document EB111/15:

The Executive Board,

Having considered the Director-General's report on assessments for 2004-2005,¹

RECOMMENDS to the Fifty-sixth World Health Assembly the adoption of the following resolution:

The Fifty-sixth World Health Assembly,

Having considered the report of the Director-General on assessments for 2004-2005 and the recommendations of the Executive Board,

DECIDES that:

(1) the assessment for the Democratic Republic of Timor-Leste be US\$ 1053 for 2002 and US\$ 4213 for 2003;

(2) as an ad hoc measure the assessment for 2003 for Afghanistan and Argentina be amended as to the amounts set out below:

(3) the difference of US\$ 611 135, resulting from the revised contributions for 2003 for Afghanistan and Argentina, should be financed from the Miscellaneous Income account;

(4) the scale of assessments for the years 2004 and 2005 shall be as set out below.
