## Contribuciones para 2004-2005

1. La finalidad de este documento es proporcionar al Consejo Ejecutivo información adicional que le ayude a examinar la escala de contribuciones de la OMS para 2004-2005.
2. El documento EB111/15 contiene en anexo un cuadro que muestra la escala de cuotas de las Naciones Unidas para diversos periodos y las escalas correspondientes de la OMS, incluida la aplicada al bienio 2002-2003; en él se expresan como porcentajes las contribuciones, y en su caso el alivio, de cada Miembro y Miembro Asociado.
3. Según se señala en el documento EB111/15 Add.1, la Asamblea General de las Naciones Unidas ha adoptado con carácter excepcional una modificación de las cuotas del Afganistán y la Argentina para 2003, así como una cuota de contribución para la República Democrática de Timor-Leste para 2002 y 2003.
4. En el anexo<sup>1</sup> a este documento se detallan, para cada Miembro y Miembro Asociado, las contribuciones en dólares de los Estados Unidos, el alivio correspondiente, si lo hubiere, y el total de las contribuciones y los alivios como porcentaje del presupuesto ordinario. Se han reflejado también las recientes decisiones de la Asamblea General de las Naciones Unidas mencionadas anteriormente, así como la cifra revisada del proyecto de presupuesto ordinario, que asciende a US\$ 867 475 000.<sup>2</sup>
5. En las columnas 2 y 3 del anexo figuran las contribuciones establecidas en la OMS para 2000-2001, expresadas en porcentajes y en dólares de los Estados Unidos.
6. En las columnas 4 a 10 se consignan los montos reales, en dólares, de la contribución y el alivio de cada Miembro y Miembro Asociado para 2002-2003.
7. La columna 11 muestra una escala de la OMS para 2002 expresada en porcentajes. Dichos porcentajes son el resultado de dividir el total de las contribuciones y los alivios, si los hubiere, consignados en la columna 10, por el total del presupuesto ordinario aprobado para 2002-2003 (US\$ 842 654 000).
8. Cabe señalar que la escala de la OMS así obtenida, reproducida también en el anexo del documento EB111/15, es comparable a la escala de las Naciones Unidas para 2002 que se muestra en ese mismo documento.

En las columnas 12 y 13 figuran las contribuciones propuestas para 2004-2005, en forma de porcentajes y en dólares de los Estados Unidos; esta última cifra resulta de aplicar el porcentaje de la columna 12 al monto del presupuesto ordinario propuesto para 2004-2005 que se financiará mediante las contribuciones señaladas (US\$ 867 475 000).
