Report by the Director-General

Rule 5 of the Rules of Procedure of the Executive Board provides that the Board "shall determine at each session the time and place of its next session".
- 2. It is proposed to convene the 151st session of the Executive Board on Monday, 30 May 2022, at WHO headquarters, Geneva. The Board may wish to consider making contingency arrangements in the event that limitations to physical meetings preclude the holding of the 151st session in May 2022 as envisaged.
- 3. An advance copy of the draft provisional agenda of the 151st session of the Executive Board is provided in the Annex, for the information of Member States.
