## TEMPLATE FOR THE EXPLANATORY MEMORANDUM FOR THE INCLUSION OF ITEMS ON THE PROVISIONAL AGENDA OF THE HEALTH ASSEMBLY

Rule 5 of the Rules of Procedure of the World Health Assembly, as amended by the Seventy-second World Health Assembly, provides that any proposal for inclusion on the provisional agenda of the Health Assembly of any item proposed by, inter alia, a Member State or an Associate Member, must be accompanied by an explanatory memorandum.

The explanatory memorandum must reach the Director-General no later than four weeks before the commencement of the session of the Board at which the provisional agenda of the Health Assembly is to be prepared.

The Seventy-second World Health Assembly further decided to recommend that the explanatory memorandum be limited to 500 words.<sup>2</sup>

In accordance with decision EB144(3) (2019), the Secretariat has developed the following template to assist Member States in submitting the explanatory memorandum referred to above.
