

Preliminary daily timetable for the Seventy-third World Health Assembly (resumed)

1. In 1979, the Thirty-second World Health Assembly, in resolution WHA32.36, decided that the Executive Board “shall fix a preliminary daily timetable for the Health Assembly’s consideration of its agenda and the General Committee shall review and approve this timetable, subsequently revising it if and when required”. At its 146th session (in February 2020), the Board considered a preliminary daily timetable for the Seventy-third World Health Assembly. Following the *de minimis* meetings of the Seventy-third World Health Assembly on 18 and 19 May 2020, the preliminary daily timetable for the resumed session of the Health Assembly is submitted herewith (see Annex) to the General Committee. The timetable has been drawn up on the assumption that the Health Assembly will wish to limit the time allowed to each speaker (Rule 55 of the Rules of Procedure of the World Health Assembly). The timetable should be considered as indicative since the actual timing of items and subitems will depend on how the work of the Health Assembly proceeds.
2. The Board decided through a written silence procedure that the Seventy-third World Health Assembly (resumed) should open on Monday, 9 November 2020, and close no later than Saturday, 14 November 2020.
