

First report of Committee A

(Draft)

Committee A held its second meeting on 23 May 2022 chaired by Dr Hiroki Nakatani (Japan).

In accordance with Rule 35 of the Rules of Procedure of the World Health Assembly, the Committee elected Dr Tamar Gabunia (Georgia) and Dr Maryam Abdool-Richards (Trinidad and Tobago) Vice-Chairs, and Dr Walaiporn Patcharanarumol (Thailand) Rapporteur.

It was decided to recommend to the Seventy-fifth World Health Assembly the adoption of the attached two resolutions relating to the following agenda item:

Special arrangements for settlement of arrears Islamic Republic of Iran

The Seventy-fifth World Health Assembly

Having considered the request of the Islamic Republic of Iran in respect of its outstanding contributions up to and including 2022 of US\$ 10 222 277; considering also the request of the Islamic Republic of Iran to reschedule payment of this balance over the period 2022–2031;

Noting that this request did not comply fully with the requirements of resolution WHA54.6 (2001) as to timing and procedure,

1. DECIDES to restore the Islamic Republic of Iran's voting privileges at the Seventy-fifth World Health Assembly on the following conditions:

The Islamic Republic of Iran shall pay its outstanding arrears of assessed contributions, totalling US\$ 10 222 277 over 10 years from 2022 to 2031, as set out below, in addition to payment of its annual assessment from 2023;

2. FURTHER DECIDES that, in accordance with Article 7 of the Constitution, voting privileges shall be automatically suspended if the Islamic Republic of Iran does not meet the requirements laid down in paragraph 1 above;

3. REQUESTS the Director-General to report to future Health Assemblies as appropriate on the prevailing situation;

4. FURTHER REQUESTS the Director-General to communicate this resolution to the Government of the Islamic Republic of Iran.

Agenda item 22.2**Special arrangements for settlement of arrears Republic of Sudan**

The Seventy-fifth World Health Assembly,

Having considered the request of the Republic of the Sudan in respect of its outstanding contributions up to and including 2022 of US\$ 239 220; considering also the request of the Republic of the Sudan to reschedule payment of this balance over the period 2023–2025;

Noting that this request did not comply fully with the requirements of resolution WHA54.6 (2001) as to timing and procedure,

1. DECIDES to restore the Republic of the Sudan's voting privileges at the Seventy-fifth World Health Assembly on the following conditions:

The Republic of the Sudan shall pay its outstanding arrears of assessed contributions, totalling US\$ 239 220 over 3 years from 2023 to 2025, as set out below, in addition to payment of its annual assessment from 2023;

2. FURTHER DECIDES that, in accordance with Article 7 of the Constitution, voting privileges shall be automatically suspended if the Republic of the Sudan does not meet the requirements laid down in paragraph 1 above;

4. FURTHER REQUESTS the Director-General to communicate this resolution to the Government of the Republic of the Sudan.
