2. 如秘书处改革实施计划（文件 EB152/34）所述，世卫组织致力于加强会员国的能见度，推进问责制和透明度。根据这一承诺，本报告现纳入规划国家自愿捐款信息——见附表 2C。

3. 截至 2023 年 12 月 31 日时的经审计的财务报表第 2.3、2.9 和 2.15 节分别概述了应收款项、递延收入和收入的会计政策<sup>1</sup>。

4. 在世卫组织和捐款方签署具有约束力的协议时，尤其按照《国际公共部门会计准则》第 23 号（“非交换交易收入”）确认自愿捐款收入。如果(a) 协议列有条件，或

(b) 总额为指示性，或在协议中未提及，仅在发放资金时确认，世卫组织则无法控制资源，仅在收到现金后才记录收入和应收款额。如果捐款方未列明付款条件，或已列明在本会计年度付款，收入在当期予以确认。如果在付款条件中列明于年末后付款，此款额记为递延收入。如果指明起始日期为下一年度，则将收入认作下一财政年度，并将收到的现金记录为预收款。

5. 每项自愿捐款记在捐款分配项下。附件所附简表汇总了这些捐款分配项，按基金和捐助方报告了收入情况。总额不足 10 000 美元的杂项收入和捐助方捐款并在一起，记在“其它和杂项收入”项下。

6. 如在 2023 年经审计的财务报表中对财务业绩报表提出的报告<sup>1</sup>，世卫组织实施的所有活动已合并到财务报告内。这包括普通基金（规划预算）和信托基金收到的自愿捐款。本报告附表 1 和 2 中报告的自愿捐款仅包括现金捐助。实物和服务捐赠在财务业绩报表中有单独报告，并在本报告附表 5 中予以详述。

7. 请参考 2023 年经审计的财务报表<sup>1</sup>，了解本参阅文件概述的详细信息。经审计的财务报表中的金额均舍入至最近的千位数或千美元。因此，由于四舍五入，本报告中的数字与财务报表和相关附注相比可能略有出入。

**Note 1.** Note 1. The core voluntary contributions account (CVCA) includes funds received to support the Programme budget as a whole, considered fully or highly flexible; and funds that are earmarked only at the level of the category. Voluntary contributions – core includes funds that are earmarked for purposes within the Programme budget, considered designated, or of a medium level of flexibility. Designated funds are also referred to as "thematic".

**Note 2.** Special Programmes and Collaborative Arrangements mainly represents revenue for activities related to poliomyelitis.

**Note 3.** The Contingency Fund for Emergencies was created in 2015 to provide temporary financing for emergency operations. For further details see Note 6.1.b.ii to the audited financial statements for 2023 (document A77/20).

**Note 4.** The WHO Staff Association Fund was created in 2018 for the activities of the Staff Association. Revenue recorded represents a transfer of flexible funds from the Office of the Director-General.

**Note 5.** The movement in the allowance for doubtful receivables is given in Note 4.3 to the Audited Financial Statements for 2023 (document A77/20).

**Note 6.** Inter-fund revenue represents the transfer of funding internally between the General Fund and the Fiduciary Fund. These funds are recorded as an expense to the " donor " fund and as revenue to the " recipient " fund and are eliminated on consolidation.

**Note 7.** Voluntary contributions are reported in the Statement of Financial Performance and detailed as part of Note 5.1 to the audited financial statements for 2023 (document A77/20).
