While countries around the globe are working through the World Health Organization to bolster health governance, WHO must ensure the participation of all stakeholders, including Taiwan. Taiwan's prolonged exclusion from WHO has seriously compromised WHO's disease prevention efforts, undermined the interests of its members, and jeopardized global health. WHO and the international community would greatly benefit from including a global health partner as willing and capable as Taiwan, as the world works to make global health architecture more resilient; improve health emergency prevention, preparedness, and response; and realize health for all.

Prior to 2017, Taiwan was invited to participate in the WHA as an observer for eight consecutive years. Taiwan's professionalism and expertise were widely recognized and acclaimed by WHO and its members. Taiwan has proven to the world that it is a valuable and indispensable partner in the collective effort to ensure that all people enjoy the highest attainable standard of health. In a world of entangled challenges, it is vital for WHO to once again invite Taiwan to attend the WHA and include Taiwan in all WHO

meetings, mechanisms, and activities, including the prospective WHO pandemic agreement and its negotiation, thereby safeguarding the right to health of the 23.5 million people of Taiwan.
