征收评定会费的状况

秘书处的报告

1. 为使世界卫生组织能充分实施经批准的规划预算，必须及时全额收到会员国的会费。根据财务条例第 6.4 条，要求所有会员国在会费应交年度的 1 月 1 日以前交纳其会费。
2. 正如于 2005 年 1 月向执行委员会第 115 届会议报告的那样，2004 年的征收率为 90%，与 2003 年的征收率相同。194 个会员国和准会员中已有 119 个交清其会费全额¹。如附件显示，截止 2005 年 3 月 31 日，2005 年会费征收率为 36%，而 2004 年 3 月 31 日时为 38%；66 个会员国已交清其 2005 年会费全额，47 个会员国已交纳部分会费。应注意到，81 个会员国对其当年会费未交纳任何数额，而 2004 年 3 月 31 日时为 68 个会员国。
3. 2004 年 12 月 31 日时欠交会费为 9100 万美元，另有经卫生大会授权特别安排下应交纳但可在今后按照分期付款计划交纳的 4600 万美元。2003 年 12 月 31 日时的相应数额分别为 1.18 亿美元和 1400 万美元。在 2004 年 12 月 31 日时欠交的 9100 万美元中，有 8400 万美元已拖欠两年以上，包括上文提及的经重新安排的欠费。在关于欠交会费程度达到可援引《组织法》第七条规定的会员国的文件中对解决其中一些长期欠费的努力作了描述²。
4. 对上述数字的进一步分析包含在向 1 月执行委员会第 115 届会议提交的报告以及未

1. SUMMARY

As of 31 March 2005, the rate of collection of annual contributions in respect of the regular budget is lower than in 2004. Out of a total amount of \$ 431 550 445, \$ 155 898 793 or 36.13% has been collected, as compared to 37.82% in 2004. Whereas 66 Members had paid their contributions in full and 47 Members in part, 81 Members had not yet paid any part of their assessment. Advance payments in respect of the year 2006 contributions are listed on page 8 of this statement.

1. RESUME

Au 31 mars 2005, le taux de recouvrement des contributions annuelles au budget ordinaire est moins élevé qu'en 2004. Pour un total de \$ 431 550 445 mis en recouvrement les encaissements atteignent \$ 155 898 793 soit 36.13% contre 37.82% en 2004. Alors que 66 Membres ont versé leur contribution en totalité et 47 en partie, 81 Membres n'ont encore fait aucun versement. Les paiements en avance des contributions pour l'an 2006 figurent en page 8 de ce rapport.
