**Nomination of a Member State to the Joint
Coordinating Board of the Special Programme for
Research and Training in Tropical Disease**

1. Composition of the Joint Coordinating Board of the Special Programme for Research and Training in Tropical Diseases

The Joint Coordinating Board of the UNICEF/UNDP/World Bank/WHO Special Programme for Research and Training in Tropical Diseases (TDR) consists of 34 members drawn from among the cooperating parties as follows:

- Twelve government representatives selected by contributors to the resources of the Special Programme;
- Twelve government representatives selected by WHO regional committees from among those countries directly affected by the diseases dealt with by the Special Programme, or from among those providing technical or scientific support to the Special Programme;
- Six members designated by the Joint Coordinating Board itself from among the remaining cooperating parties;
- The four Agencies that comprise the Standing Committee (UNICEF, UNDP, World Bank and WHO).

Members of the Joint Coordinating Board serve for a period of three years and may be reappointed.

From the Eastern Mediterranean Region, the Islamic Republic of Iran, Libyan Arab Jamahiriya, Syrian Arab Republic and United Arab Emirates are currently members of the Joint Coordinating Board. The term of office of the Syrian Arab Republic will expire on 31 December 2009, and it was informed of the mechanism for re-selection to Joint Coordinating Board membership from 2010.

The Regional Office invited Member States for apply to vacancies that exist under paragraph 2.2.3 of the Memorandum of Understanding (members selected by the Joint Coordinating Board itself). The Islamic Republic of Iran and Japan were selected under this paragraph. The Islamic Republic of Iran is the only contributor to the TDR resources from the Region.

2. Observer Status on the Joint Coordinating Board

Other cooperating parties may, on request, be represented as observers, upon approval by the Joint Coordinating Board. Member States of the Eastern Mediterranean Region who have observer status are: Egypt, Iraq, Jordan, Kuwait, Morocco, Pakistan, Saudi Arabia, Sudan, Tunisia and Yemen.

3. Member States selected by the Regional Committee for the Eastern Mediterranean to the Joint Coordinating Board

The following Member States were previously selected by the Regional Committee for the Eastern Mediterranean to the Joint Coordinating Board:

As of 1 January 2010, there will be one vacancy from the Eastern Mediterranean Region to replace the Syrian Arab Republic, whose term of office will end on 31 December 2009. This vacancy exists under paragraph 2.2.2 of the Memorandum of Understanding (Members selected by the WHO regional committees). The Regional Office invited the Member States to apply for this vacancy. The following Member States have applied:

- Oman
- Iraq
- Egypt
- Sudan

The Regional Committee is requested to nominate one Member State to serve on the Joint Coordinating Board for a four-year period, 1 January 2010 to 31 December 2013.
