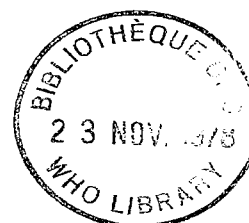

SMALLPOX VACCINATION CERTIFICATE REQUIREMENTS ^a

As smallpox vaccination certificate requirements and national health legislation on routine smallpox vaccination are rapidly changing the Smallpox Eradication Unit periodically updates information on these regulations. This information will be useful in developing future recommendations on smallpox vaccination policy, both before and after global smallpox eradication is certified.

Smallpox vaccination certificate requirements

In 1976 the Twenty-ninth World Health Assembly, in resolution WHA29.54, urged, inter alia, all governments to restrict their requests for smallpox vaccination certificates to travellers who, within the preceding fourteen days, had visited a smallpox-infected country as reflected in the Weekly Epidemiological Record.

Based on official information sent to WHO for publication in "Vaccination Certificate Requirements for International Travel" for 1978, 69 countries (or areas) out of a total of 199 countries (or areas) require a smallpox vaccination certificate from all arrivals, and 128 require a certificate from arrivals from countries (or areas) in which there are smallpox-infected regions (see Table 1 and Figure 1). ^c However, these 128 countries, in effect, do not require smallpox vaccination certificates as there are no smallpox infected areas in the world at the present time. A list showing the status of smallpox vaccination certificate requirements for international travellers and obligatory routine smallpox vaccination according to national health legislation is available from the Smallpox Eradication Unit, Geneva.

Routine smallpox vaccination

In the report of the Consultation on Worldwide Certification of Smallpox Eradication held in Geneva from 11 - 13 October 1977, it is stated that vaccination policy between the present time and final certification should be determined by each government depending on its own assessment of risks and benefits. Subject to this, it is the opinion of the Consultation that routine vaccination is clearly indicated only in countries in Africa and Asia where smallpox has been endemic during the last few years, and in those at specific epidemiological risk. When global eradication is certified, termination of vaccination will be recommended.

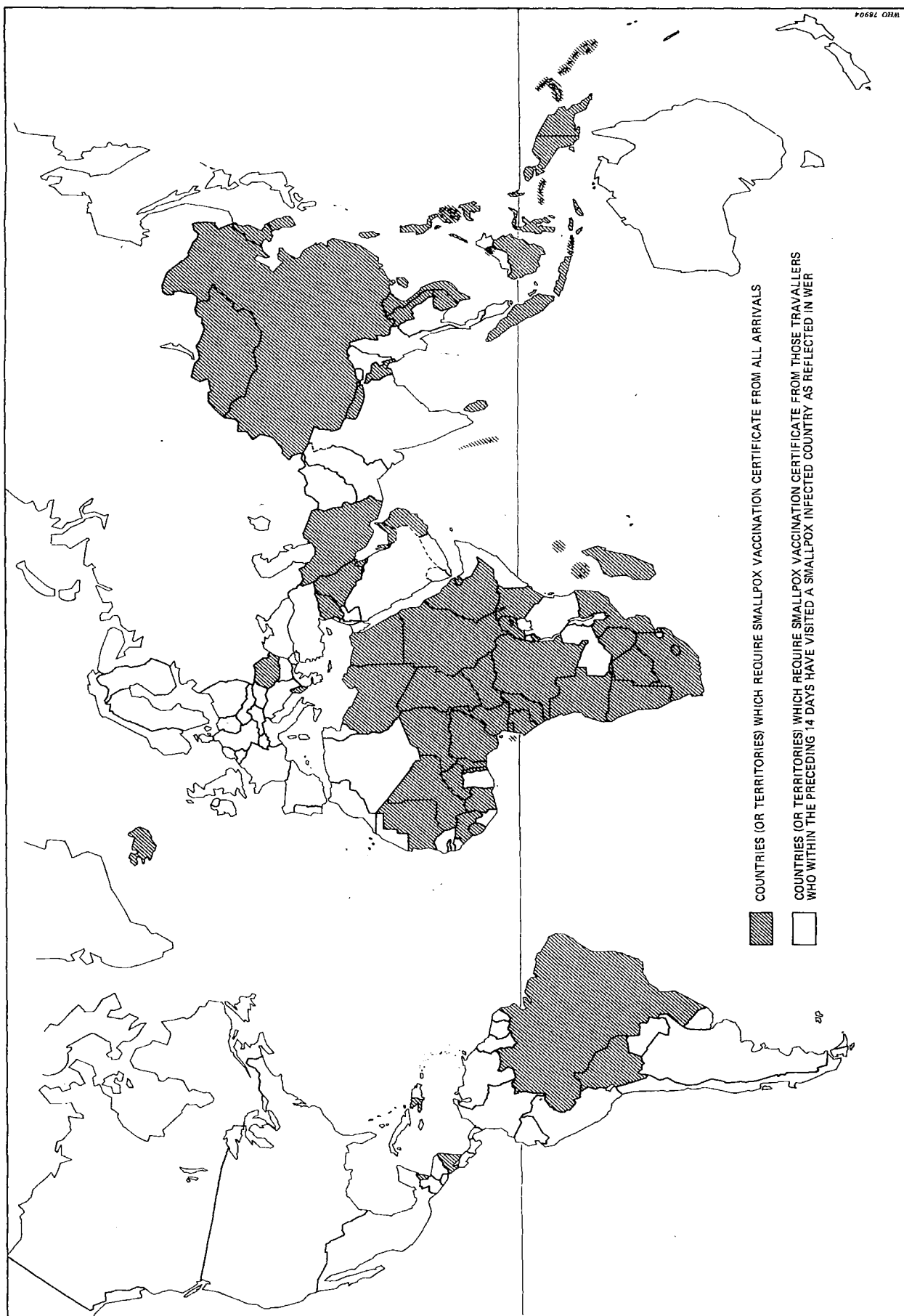


Fig. 2 COUNTRIES WHERE ROUTINE SMALLPOX VACCINATION IS NOT OBLIGATORY

According to information available at WHO Headquarters, routine smallpox vaccination is no longer obligatory in 44 countries, following appropriate changes in national health legislation (see Table 2 and Figure 2).
